ATI Advisory Group Guidelines

RESPONSIBILITIES

The ATI Advisory Group is expected to meet monthly (initially virtually and possibly in person as needed) for one year (April 2022 through February 2023) and will be composed of 10-15 community members who applied and were selected through an objective review process to represent diverse perspectives and experiences. As a member you are expected to be able to attend and actively engage in the majority of these meetings. The Advisory Group will be provided with regular updates on the research process and asked to provide their input on the research as it evolves, as well as recommendations that may be made for the data and information that are compiled. To ensure transparency, all meetings of the Advisory Group will be public and recorded.

You were selected to serve as an Advisory Group member due to your experience and expertise. The interests of the public with regard to the input you provide may or may not coincide with the interests of the public or private organization you represent or with your personal interests. Since the funds used by SANDAG to carry out its responsibilities are public funds, however, you will be expected to participate in the Advisory Group using objective standards that will best serve the interests of the public and SANDAG. When meeting with others involved in the Advisory Group, you will be expected to be respectful and allow everyone to speak an equal amount of time. Advisory Group members do not have authority to make final decisions; only to make recommendations.

Advisory Group Activities Since April 2022

- Orientation and five public meetings
- Participated in June community forums
- Provided input on community engagement and community surveys
- Pre-tested community surveys
- Reviewed scope for gap analysis and led to creation of service provider survey
- Discussion and feedback included in Second Interim Report recommendations
- Working Groups formed and have met since August 9th

ATI Working Groups

- SANDAG staff coordinated a total of 9 subgroup meetings which include participation by 12 of the 14 Advisory Group members.
- Some of the most relevant issues discussed include:
 - Practices that would have been beneficial prior to arrests
 - Successful social enterprises (e.g., Delancey Street)
 - Disparities created by systemic issues in existing practices and programs
 - Barriers to implementing changes in the local criminal justice system
 - Other topics that fall outside of the scope of the current project (e.g. incarceration, bail, etc.).
- Both Subgroups agreed on putting together an AG authored piece to include as an addendum in the final project report
