Crime in the San Diego Region Mid-Year 2022 Statistics

Introduction

Since 1980, SANDAG has been compiling and reporting regional crime statistics for San Diego County and remains the only local source for regional statistics not available at the national level. This summary presents information regarding how many and what types of Part I crimes were reported to local law enforcement in the first half of 2022 and how these numbers compare to prior years (including one and five years ago).

Violent crime

- A total of 6,182 Part I violent crimes were reported to local law enforcement agencies in the region between January and June 2022 (Tables 1 and 6). Part I violent crimes include homicide, rape, robbery, and aggravated assault. This number was higher than what was reported in 2021 (2%) and 2018 (12%) (Table 1).
- The violent crime rate of 3.73 per 1,000 inhabitants was the highest it has been in the ten-year comparison period which has included annual increases and decreases (Figure 1).
- Of the 18 jurisdictions with violent crime numbers that were large enough to compare in 2021 and 2022, 10 had a higher violent crime rate in the first six months of 2022 and 8 had a lower rate (Table 3).
- There were 51 homicides in the first half of 2022, 4% more than at mid-year 2021 and 28% higher than mid-year 2018 (Table 1).
 - For the 32 homicide incidents in which a motive could be determined (to date) in 2022, arguments were the most frequent (63%), followed by gang involvement (13%), domestic violence (9%), lover's triangle (6%), and 3% respectively for robbery, burglary, and institutional killing (not shown).
- There were 475 rapes reported to law enforcement in San Diego County in the first half of 2022, fewer than the number reported in the first half of 2021 (532), and 2018 (604) (Table 1).
- The number of robberies reported across the region increased 15% from mid-year 2021 (1,176) to 2022 (1,355). This mid-year total was also 1% higher than the reported total at mid-year 2018 (Table 1). As part of the standardized Uniform Crime Reporting (UCR) reporting requirements, the type of weapon used during a robbery is documented.
 - For mid-year 2022, 18% of the robberies involved another type of weapon (e.g., bat, stick, or other blunt object), 16% a firearm, 13% a knife or cutting instrument, and the majority (54%) were considered strong-arm (committed with a threat of force or intimidation that usually does not involve a weapon) (not shown)

Highlights

Six months into 2022, the annualized mid-year violent crime rate of 3.73 was 2% higher than it was at mid-year 2021 (when it was 3.66). This increase reflected a greater number of reported robberies and homicides during the first six months of 2022, compared to 2021.

In comparison, the annualized mid-year property crime rate of 15.95 was 2% lower than the 16.30 reported at mid-year 2021. Overall, burglaries were up 10%, but this increase was driven by a 19% increase in non-residential burglaries (residential burglaries were down regionally by 2%). In addition, the number of reported larcenies was down 6%, but motor vehicle theft continued to increase (up 4% from mid-year 2021 to mid-year 2022).

- Each type of robbery increased over the past year, from those with firearms with a slight increase of <1%, to strong-arm with 16%, with a knife or cutting instrument with 20%, and other types of weapons which increased 24% (not shown).
- The 4,301 aggravated assaults reported during the first six months of the year represented a decrease of <1% from the prior year but a 22% increase from five years ago (Table 1). In 2022, 35% of the aggravated assaults involved the use of another dangerous weapon, 31% strong arm, 19% knife or other cutting instrument, and 15% a firearm.
 - Aggravated assaults that involve use of strong-arms (hands, fist, feet, etc.) increased more than any other type of assault (10%, compared to 5% increases for knife or cutting instruments, and decreases in firearms (17%) and other dangerous weapons (3%)) (not shown).
- There were 8,554 domestic violence incidents reported in the first half of 2022, a 4% decrease from the 8,938 reported in the first half of 2021, but a 2% increase from the first half of 2018 (Table 12).

Property crime

- A total of 26,448 property crimes were reported to local law enforcement agencies in the first half of 2022 (Tables 1 and 7). This was 2% lower than it was during the first half of 2021, and 5% lower than the first half of 2018. Property crime includes burglary, larceny, and motor vehicle theft.
- The mid-year 2022 property crime rate of 15.95 was the second lowest rate in the past ten years (Figure 2).
- Of the 25 jurisdictions with property crime numbers that were large enough to compare in 2021 and 2022, 14 had a higher property crime rate in 2022 compared to 2021, and 11 had a lower one (Table 4).
- The 3,867 burglaries reported in the San Diego region in the first half of 2022 represented an increase of 10% from the first half of 2021 (when there were 3,525). This increase reflected a 19% increase in non-residential burglaries, and a 2% decrease in residential burglaries (Table 1).
 - A greater percentage of burglaries in the first half of 2022 involved forced entry (61%), compared to 2021 (57%) (not shown).
- The number of larcenies reported in the region at mid-year 2022 (16,903), represented a 6% decrease from mid-year 2021 (18,032). The most common type of larceny at mid-year 2022 was theft from inside motor vehicles (38% followed by from buildings (25%). Five types of larcenies were down over the past six months (pickpocketing -3%, others -4%, shoplifting -5%, bicycle theft -11%, and from motor vehicles -15%.) while other categories were up, including from buildings (3%), and motor vehicle parts (12%). Forty-four percent (44%) of larcenies were petty thefts involving property valued at \$400 or less (Table 1).
- Motor vehicle theft increased 4%, from 5,462 vehicles stolen at mid-year 2021 to 5,678 at mid-year 2022. This 2022 number was also 21% higher than the 4,681 reported in mid-year 2018 (Table 1).

Background

The ability for SANDAG to analyze data and produce reports on crime trends for the region relies upon a cooperative agreement with each local law enforcement agency. SANDAG obtains crime data from every agency on a monthly basis, allowing the presentation of regional crime data in a timely manner.

Crimes are categorized according to the FBI's standardized UCR guidelines for law enforcement agencies across the country. Reported crimes are tallied in ARJIS according to the date of data entry, which may or may not reflect the day of occurrence. It should be noted that while local law enforcement agencies strive to tabulate their statistics in a timely fashion, data entry delays sometimes occur, which may affect statistics.

The mid-year crime rates per 1,000 residents are estimated by multiplying the number of crimes reported between January and June by two and dividing that number by the population which has been divided by 1,000.

The statistics presented in this CJ Bulletin include crime rates and numbers for San Diego County and individual jurisdictions for the first half of 2022. Comparisons are made to prior years. The number and type of crimes that are reported can be influenced by several factors, including the degree of opportunity to commit crimes in a given jurisdiction, which can be related to the amount of commercial land use and ease of access to the area. It should be noted that as of 2022 California Highway Patrol, California State University San Marcos, and California State Parks had already transitioned to the new reporting system (CIBRS)¹. As such, crime rates and other comparisons to previous years in the appendix tables for these agencies are not represented. Due to the small number of crimes these agencies represented in previous year totals, these missing data do not have a significant effect on regional totals and rates presented here.

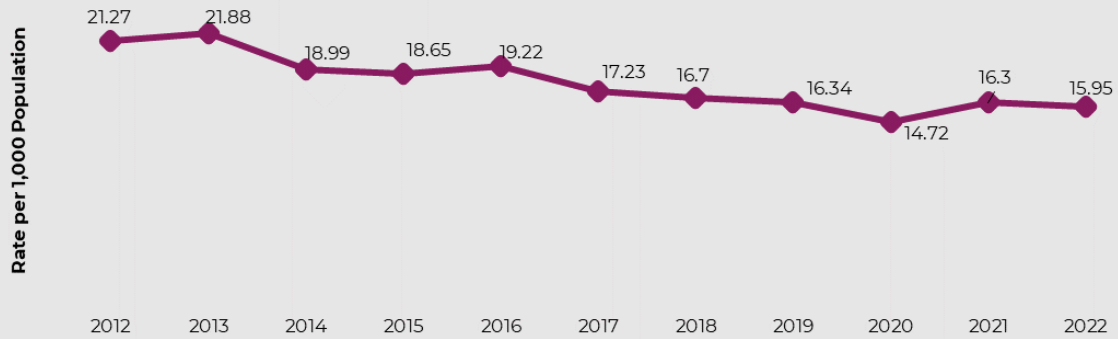
¹ It should be noted that San Diego County law enforcement agencies are in the process of transitioning to the California's Incident Based Reporting System (CIBRS), which allows for more timely and comprehensive data analysis including information regarding a greater number of incident types and characteristics. SANDAG reports will be updated as new standardized regional information is available with full transition completion expected by early 2023.
