## MEMBERSHIP

The Social Services Transportation Advisory Council (SSTAC) is an advisory group to the San Diego Association of Governments (SANDAG). SSTAC consists of 21 members representing social service agencies, individuals, transportation providers, and the Consolidated Transportation Services Agency. The California Public Utilities Code requires SSTAC to hold at least one public meeting each year to solicit input on transportation needs from seniors, persons with disabilities, and persons with limited means. SSTAC works to respond to federal and state requirements, as well as local concerns, regarding accessibility issues. Responsibilities include reviewing and providing guidance on federal funding programs for the elderly and disabled, coordination of vehicles for elderly and disabled persons, special studies, and providing input on the legal and practical requirements regarding accessibility at transit facilities.

The Social Services Transportation Advisory Council generally meets at 10 a.m. on the third Tuesday in odd-numbered month.
