

SANDAG Vanpool Program FY27 Promotion Official Rules

These rules govern the SANDAG Vanpool Program FY27 Promotion being conducted by the San Diego Association of Governments (SANDAG) beginning on August 15, 2026 at 12:00 a.m. PT.

1. HOW TO PARTICIPATE

Individual commuters can participate in the SANDAG Vanpool Program FY27 Promotion by following the below method:

A. NEW VANPOOL PROMOTION (Promotion). Up to ten (10) new vanpools formed after the start of the Promotion will be eligible for a \$200 value in gas cards after enrolling in the SANDAG vanpool program and signing the lease of a vehicle with Enterprise. A member of Enterprise will provide the gas cards upon signing the lease. The vanpool may be new to the SANDAG Vanpool Program or may be a vanpool restarting in the SANDAG Vanpool Program.

ELIGIBILITY RESTRICTIONS

The Promotion is open to all persons who are 25 years of age or older and who work in San Diego County. The Promotion will be awarded to the vanpool leaseholder, or the party responsible for the vehicle lease. New vanpools must have eighty (80) percent vehicle start-up occupancy and have a work destination in San Diego County. Employees of SANDAG, the members of their immediate families (spouse, parent, sibling, or child), and those living in the same household of each (whether related or not), are ineligible to receive the promotional benefit. Contractors or consultants of SANDAG who are currently working on any Sustainable Transportation Services programs also are ineligible to receive the promotional benefit. This Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. SANDAG will disqualify any individuals who do not meet these eligibility requirements.

VANPOOL PROMOTION AWARD

A value of \$200 will be issued in the form of gas cards. A maximum of (10) vans will be awarded after the start of the Promotion on a first-come, first-served basis as participants meet the requirements

2. CONDITIONS

Decisions made by SANDAG management with respect to the Promotion are final.

The Promotion Program are governed by and subject to the laws of the State of California and the United States as applicable. All federal, state, and local laws and regulations apply. Void where prohibited by law.

The Promotion is expressly limited to the items listed above and there is no substitution, transfer, or cash equivalent, except that SANDAG may, at its sole discretion, substitute an award of comparable value. SANDAG is not responsible for prize utility, quality, or otherwise.
