October 1, 2025, Meeting Minutes

Chairwoman Erica M. Pinto (Jamul Indian Village of California) called the meeting of the Interagency Technical Working Group on Tribal Transportation Issues to order at 10:08 a.m.

1. Welcome and Introductions

Chairwoman Erica M. Pinto provided a welcome and introduction for the Tribal TWG meeting and asked attendees to introduce themselves. Councilmember Jack Musick of the La Jolla Band of Luiseño Indians led the group in a blessing.

2. Member Comments/Communications

Tribal TWG members were given the opportunity to provide information, updates, and announcements. No information was shared.

Consent

3. Approval of Meeting Minutes

Working group members approved the meeting minutes for the June 25, 2025, meeting.

Reports

4. Co-Chairs' Report

Chairwoman Erica M. Pinto shared updates on California Native American Heritage Day, a Tribal Scholarship Program, and meetings attended with the U.S. Department of Health and Human Services and the Tribal Chairpersons Association. Pinto also encouraged tribal leaders and staff in attendance to utilize the Tribal Technical Assistance Program.

SANDAG Senior Director of Regional Planning Antoinette Meier announced that staff continue to advance projects on I-8/Willows Road and SR 76. Additionally, the 2025 Regional Plan Draft Environmental Impact Report is out for public comment, and SANDAG is hosting a Climate Workshop on October 8. Meier also shared that SANDAG's Vision Zero Action Plan is complete, and the newly kicked-off Vision Zero Taskforce is seeking tribal representation, as is the California-Baja California Border Resilience Plan Taskforce. Meier also announced that SANDAG has been awarded a Caltrans Planning Grant for a Rural Corridors Study to enhance roadway safety on and near tribal lands. Finally, Meier shared that SANDAG has received a letter requesting voting representation for tribes on the SANDAG Board of Directors. SANDAG's outside counsel is conducting an analysis and more information will be shared with SCTCA.

Action: Information only.

5. Caltrans Tribal Agreements

Caltrans District 11 Tribal Liaison Karen Islas presented on the avenues available for tribes to enter into agreements with the agency to advance tribal transportation projects. Tribal members asked several questions pertaining to funding opportunities shared by Islas. Staff will follow up with information.

In discussion, SANDAG Senior Director of Regional Planning Antoinette Meier added that the next cycle of Caltrans Planning Grant applications has been released and that SANDAG staff assistance is available.

2024 Tribal Summit Update

Overview

Interagency Technical Working Group on Tribal Transportation Issues co-chairs will share updates on some of the recommendations that came from the 2024 Tribal Summit. The Tribal Summit has typically been held every four years between the San Diego Association of Governments (SANDAG) and the Southern California Tribal Chairmen's Association (SCTCA). The purpose is to bring together elected leaders from the 19 local governments that make up the SANDAG Board of Directors and the 17 federally recognized tribal governments in the San Diego region to discuss policy issues of mutual interest related to transportation and regional planning.

Action: Information

Updates on progress made since the 2024 Tribal Summit will be shared.

Fiscal Impact:

Work on the Tribal Summits and outcomes is funded through the Tribal Program OWP, 3100404.

Schedule/Scope Impact:

This work entails ongoing coordination via the SANDAG SCTCA MOU and will inform upcoming collaboration efforts.

Key Considerations

Discussions from the 2024 Tribal Summit resulted in several comments or recommendations. A summary of discussions and outcomes that have taken place since the Summit was held is included below:

- **Increase the frequency of Tribal Summits.** Tribal leaders have expressed a desire to hold annual Tribal Summits. After leadership discussions in late 2025, SANDAG and SCTCA leaders have agreed to Tribal Summits every two years. Additionally, SANDAG and SCTCA leadership have agreed to a regular cadence for leadership meetings focused on advancing specific tribal priorities.
- **Add voting power for tribal advisory representative on the SANDAG Board of Directors.** SCTCA formally requested three voting seats on the SANDAG Board of Directors in the fall of 2025. The make-up of SANDAG's voting members is determined by the state legislature and not something that SANDAG has authority over. Changes made to voting structure at SANDAG would require a change by the state legislature. SANDAG and SCTCA are continuing discussions on steps to move forward.
- **Prioritize fair funding distribution for rural projects/create a tribal set aside.** SANDAG and SCTCA leadership continue discussions on funding for tribal priorities. To secure additional funding for tribal priorities, SANDAG supported several grant efforts in 2024 and 2025:
 - A Tribal Housing Grant Program administered by SANDAG and SCTCA through SANDAG's Regional Early Action Planning allocation to award approximately \$4.4 million to eight tribes to advance housing planning efforts on or near tribal reservations in the San Diego region.
 - An awarded \$250,000 Caltrans Strategic Partnerships Planning Grant for a Rural Corridors Study. Efforts to begin in 2026.

- A Caltrans Sustainable Transportation Planning Grant application for an Advanced Air Mobility (AAM) Infrastructure Readiness and Integration Strategy for \$700,000. Notification expected by Summer 2026.
- A 2025 Safe Streets and Roads for All (SS4A) program application to address safety improvements at two intersections on Caltrans-owned facilities on tribal lands. Award not received.
- An awarded Safe Streets and Roads for All Grant for the SANDAG Regional Vision Zero Action Plan to advance traffic safety goals for the San Diego region in 2024. The La Jolla Band of Luiseño Indians was jointly awarded funds and the tribe and SANDAG worked closely to complete a similar plan for the La Jolla Band.
- In 2026, SANDAG will release a call for projects for a Flexible Fleets Pilot Grant Program. Tribes will be eligible to apply. \$4.5 million expected to be available regionally.
- **Bridge the gap between the current CEQA letter-writing process and planners' understanding of tribal cultural and natural resources.** The Tribal Consultation Process is an important part of SANDAG's environmental compliance efforts. To strengthen this process, SANDAG has begun to develop tribal sovereignty education materials to share with all staff and incoming SANDAG board members. Furthermore, SANDAG has added language to the new agreement with SCTCA to support additional education, information and communication related to the environmental review for SANDAG project under CEQA. These conditions have been included in the mitigation requirements of the Environmental Impact Report (EIR) for the SANDAG 2025 Regional Plan.

Next Steps

Over the coming months, staff will continue discussions with SCTCA to identify a date for the next Tribal Summit. SANDAG and SCTCA leaders will meet again in early 2026 for continued discussion on key topics. The next Interagency Technical Working Group on Tribal Transportation Issues meeting will take place in early Spring. As grant notifications are received, tribes and SCTCA will be informed. SANDAG staff will work with SCTCA staff to review tribal education materials.

 - Awarded Rural Corridors Study: Improving Transportation Infrastructure on or near Tribal Lands with SANDAG is lead applicant, awaiting Notice to Proceed (NTP)
- **Caltrans Sustainable Transportation Planning Grant Program – Sustainable Communities FY 26/27**
 - Advanced Air Mobility with Viejas Band of Kumeyaay Indians is lead applicant, SANDAG, Pala Band of Mission Indians, Mesa Grande Band of Mission Indians, and Lipay Nation of Santa Ysabel as sub-applicants; Expected Award Announcement in Spring/Summer 2026
- **Safe Streets and Roads for All (SS4A) 2025 Implementation Grant**
 - Improvements to SR 79 and School House Canyon Road and SR 76 and Pauma Reservation Road with SCTCA as lead applicant; Grant was not awarded
- **Regional Early Action Planning Grants of 2021 (REAP 2.0) Tribal Housing Grant Program**
 - Awarded \$4.4 million to 8 tribes in the San Diego region; June 30, 2026 expenditure date
- **SANDAG Flexible Fleets Pilot Grant Program**
 - Awaiting release of the Call for Projects; \$4.5 million will be available for local, state and federal agencies, tribal governments, military institutions, and transit districts in the region

Ashwood Street Corridor Improvements

• Project Overview

- Location: Ashwood Street between **SR-67** and **Wildcat Canyon Road**, Lakeside Community
- Project length: approximately **1.3 miles**
- Purpose: improve **safety, traffic flow, and multimodal access**

- Roadway widening and realignment
- New left-turn lanes
- Traffic signals at:
 - El Capitan High School entrance
 - Willow Road intersection
- Sidewalk and trail improvements

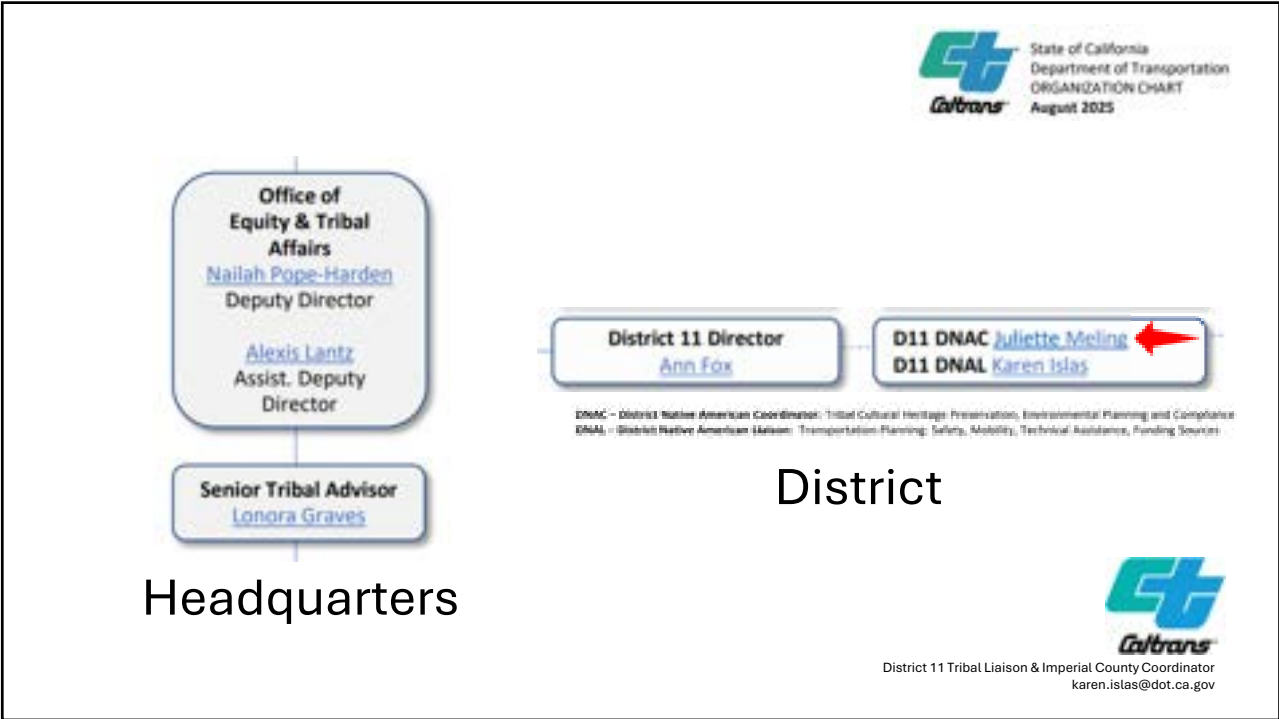

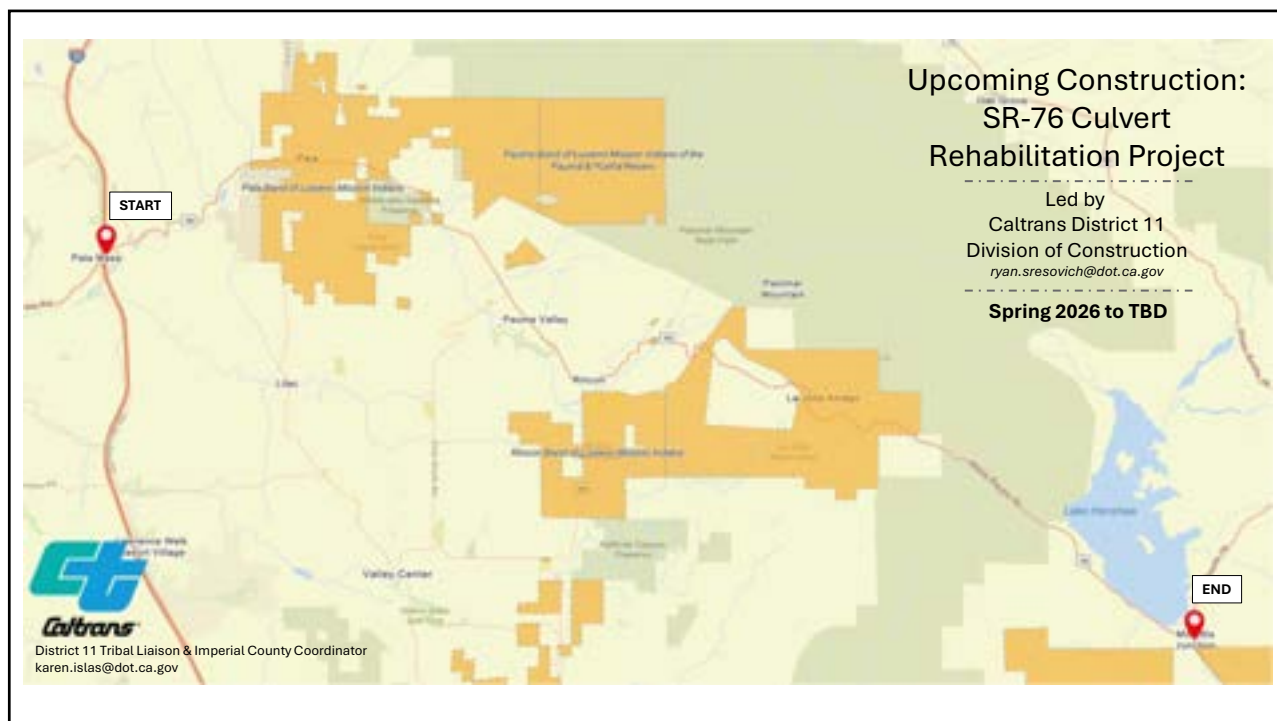

Draft Community Engagement Guidance for Plans and Projects: A Statewide Playbook

Factsheet

The "Draft Community Engagement Guidance for Plans and Projects: A Statewide Playbook" (known as the Statewide Playbook) is a comprehensive internal guide in development by Caltrans to foster meaningful and equitable community engagement throughout the planning and project delivery processes. This factsheet provides information about the Statewide Playbook.

Purpose

- To foster engagement with all affected stakeholders (Tribes; local, regional, and state government entities; community groups; and the public) across planning and project delivery.
- To build trust through increased transparency and improved communications at all stages of the planning and project delivery process.

Background

- Aligns with Caltrans' Strategic Plan and Equity Statement, promoting meaningful and equitable community engagement to create a more prosperous future for all Californians.



- Developed as a reference for staff to conduct engagement in the planning and project delivery process.
- Highlights best practices and successful approaches for community engagement, emphasizing creative solutions.

Key Principles

- **Transparency:** Provide clear and timely information on Caltrans's plan and project processes and decision points.
- **Engagement:** Work with local, regional, and state governments entities, stakeholders, and the public to develop solutions.
- **Equity:** Meeting people where they are to ensure access and participation.
- **Accessibility:** Provide clear, multilingual information in formats everyone can use. Ensure meeting spaces are welcoming to people of all abilities.
- **Follow-Up:** Report back on how input was used and what decisions were made.
- **Continuity:** Ensure input is received early and is carried through the life of the project.



Tools and Resources

- **Caltrans Engagement Portal:** An online tool to collect, manage, and measure public input on Caltrans plans and projects.
- **Visualizations:** Illustrations that breakdown and convey complex transportation information and facilitate public understanding.
- **Public Engagement Plan (PEP):** An internal tool that helps project teams identify stakeholders and describes how they will be involved in the planning and decision-making process.
- **Equitable Engagement Toolbox:** An internal repository for information, best practices, templates, trainings, and tools to conduct equitable engagement.

Engagement Strategies

- **Internal Collaboration:** Involve Caltrans subject matter experts early to develop and deliver consistent messaging to reduce miscommunication and stakeholder engagement confusion.
- **Jurisdictional Engagement:** Engage local, regional, and state government entities early to leverage knowledge and resources, hold regular dialogue to reduce community engagement fatigue, and synergize efforts.
- **Tribal Engagement:** Adhere to government-to-government relationships with tribes, utilizing Caltrans Native American Liaisons and Coordinators for effective consultation.
- **Community Based Organizations (CBOs):** Outreach and involve CBOs to reach underserved populations, and leverage their knowledge and networks. Whenever feasible, compensate them fairly for their participation.
- **Public Engagement:** Go where community is and utilize a combination of in-person and virtual formats to ensure comprehensive and inclusive community engagement.

Tribal Priority Projects Update

Overview

San Diego Association of Governments (SANDAG) is advancing two tribal priority projects identified through coordination with the Southern California Tribal Chairmen's Association (SCTCA) and tribal nations to address safety, access, and mobility needs near and on tribal reservations: improvements to Interstate 8 (I-8) at West Willows Road and the State Route 76 (SR 76) straightening project.

The projects included in this report are identified as tribal priorities in the [2022 Intra-regional Tribal Transportation Strategy \(ITTS\)](#). The ITTS is the result of a collaborative effort between SANDAG and the SCTCA to identify tribal transportation needs in the San Diego region.

Key Considerations

I-8 at West Willows Road Improvements

This Interchange is approximately 32 miles east of downtown San Diego and serves as the western gateway to the Viejas Band of Kumeyaay Indians tribal nation, as well as the Viejas Casino & Resort. Planned improvements are intended to enhance operational efficiency, improve safety for all users, and support reliable access to tribal lands.

The project is currently in the early planning phase. Current work includes collecting traffic information, beginning environmental studies to understand potential impacts, identifying and tracking potential project risks, gathering location records, developing base maps, and beginning outreach efforts. This early work will help guide future project design, environmental review, and project costs.

SR-76 Roadway Straightening

This project is scoped to perform a planning level assessment of alternatives to address infrastructure improvement for the purpose of increasing safety and efficiency on SR-76. The five-mile project extent runs between Horse Ranch Creek Road on the west end and Pala Mission Road on the east end. The procurement of a consultant was completed, and a notice to proceed was issued on December 10, 2025.

Next Steps

Over the coming months, staff will continue early planning activities for the I-8 at Willows Road Improvements Project. This includes traffic and safety analysis, initial environmental studies, and refinement of the project purpose and need. Staff will also continue coordination with the Viejas Band of Kumeyaay Indians and other tribal nations, along with community outreach, to inform future project design and environmental review. Tribes along the SR 76 corridor will receive an invitation to participate in the Project Development Team in early 2026. The initial planning work takes approximately one year to complete. I-8 and Willows Road initial planning is anticipated to be completed by fall 2026; SR 76 is anticipated to be completed by summer 2027.
