**MANAGEMENT COMMITTEE DISCUSSION AND ACTIONS**

Meeting of February 6, 2008

1. ROLL CALL

Chair Clifford Diamond (El Cajon Police Department) called the meeting to order at 9:30 a.m. See attendance sheet on last page.

2. APPROVAL OF DECEMBER 5, 2007 MEETING MINUTES (APPROVE)

Upon a motion by Chief Alan Lanning (La Mesa Police Department) and a second by Chief Adolfo Gonzales (National City Police Department), the Management Committee unanimously approved the minutes of December 5, 2007.

3. PUBLIC COMMENTS/COMMUNICATIONS/MEMBER COMMENTS

No members of the public were present.

Undersheriff Bill Gore (San Diego Sheriff's Department) asked if there was any response back from Miramar about the Emergency Vehicle Operator Course (EVOC).

Chief Richard Emerson (Chula Vista Police Department) reported he received a letter from the base commander at Miramar Air Station denying access to the base for a new EVOC. The reason for denial was stated that it would be in the emergency landing zone.

Rich Gorman (Director, High Intensity Drug Trafficking Area (HIDTA)/Imperial Valley) stated there is another group similar to Blackwater that is trying to put in another course and would open it for free to law enforcement agencies.

Pam Scanlon (ARJIS Executive Director) stated that the Public Safety Committee has recommended forwarding the issue of finding suitable land available for an EVOC to the SANDAG Board for ideas.

**REPORTS**

4. PUBLIC SAFETY COMMITTEE UPDATE (INFORMATION)

The Public Safety Committee met on January 18, 2008. At this meeting, FBI Special Agent in Charge Keith Slotter presented to Ms. Pam Scanlon and ARJIS the FBI Director's Award for

their outstanding work in providing support for law enforcement entities and communities in San Diego County. The next Public Safety Committee meeting is scheduled for Friday, February 15, 2008.

5. A PRIVATE/PUBLIC PARTNERSHIP: IMPROVING SITUATIONAL AWARENESS FOR LAW ENFORCEMENT OFFICERS (INFORMATION)

Dale Stockton (ARJIS Project Manager) presented a PowerPoint presentation on Phase 1 of the Situational Team Awareness and Reporting (STAR) Project.

Undersheriff Gore inquired if the deputy/officer in the field would see everyone in the field.

Mr. Stockton said that everyone within that task force would be shown. It is possible to turn off the GPS feature on the PDA as well.

Ms. Scanlon stated that it is important for task force members to see where other agents are in the field for officer safety.

Chief Lou Scanlon (Coronado Police Department) asked if it could be set up for only the supervisor to see.

Mr. Stockton said it could be reset; however it is great feature to see where partners are.

Chair Diamond inquired on how accurate the locations are.

Chief Lanning asked on how fast the locators are.

Valerie Wentworth (Qualcomm Product Manager) stated that the refresh rate is about 2 minutes with the handheld. There are no dots moving on the map, but it is a global positioning system (GPS) fix. The workable cell phone is set up to allow the battery to be used for the entire shift.

Captain Reginald Grigsby (Oceanside Police Department) asked if the information could be downloaded later.

Mr. Stockton stated the information could be downloaded. There is an option for stealth mode. The supervisor can turn back on. It is a safety and information issue. The San Diego Police Department piloted the units with their Beach Team and Gang Unit as well as the Motor Group in Carlsbad. Messaging was a popular feature as well as cost effective with using off-the-shelf cell phones. The Aerial unit loved it, being able to accurately locate officers.

Chief Lanning asked if the user identifiers show on the map.

Mr. Stockton said it did.

Undersheriff Gore stated that if every department and officer had this, it wouldn't burden the voice side.

Ms. Wentworth agreed. This is a data application that never gets saturated. She reminded the Committee that the carriers also have priority service for Voice "feature code".

Mr. Stockton says there is potential expanded usage if the device is used for query, voice, and data and integration with different systems. The goal is to locate a signal on the Computer Aided Dispatch (CAD) map to eliminate the need to access a separate web site. The technology exists for sending photos in the field as well as push to talk. One problem is there is no geo-referencing of existing buildings (indoor accuracy). For example, you would not know what floor the person is on. There is a request to National Institute of Justice (NIJ) to merge Global Query and position location. There is also a similar request to Immigration and Customs Enforcement (ICE). This phase uses GPS one (location) technology.

6. ROAD RUNNER (SAN DIEGO IMPERIAL COUNTY LPR PROJECT) (DISCUSSION/POSSIBLE ACTION)

Mr. Gorman and Mr. Stockton gave a status update on the license plate reader (LPR) project. Mr. Gorman stated the goal is to make a consolidated system with all LPR systems able to talk with each other. Mr. Gorman stated that ARJIS is regional in concept and suggested that ARJIS could be used as a centralized server and governance. This project needs to be operational by August 2008. Mr. Gorman stated he is meeting with the Space and Naval Warfare Systems Command (SPAWAR) to talk about ARJIS's role. Mr. Stockton stated the need for an approach that complies with the Office of National Drug Control Policy (ONDPC) and would also benefit ARJIS. Each agency would have their own server. It was proposed that agencies such as the Federal Bureau of Investigation (FBI) and Naval Criminal Investigative Service (NCIS) could access for a fee.

Undersheriff Gore asked about the impact on other ARJIS priorities and the staffing requirements.

Chief Gonzales inquired about the need for more space on the server.

Mr. Stockton stated that there may be a need for another server if ARJIS is the over-arching server.

Ms. Scanlon stated that ARJIS governance is important, resources are tight; and that additional resources and funding would be required to successfully implement this as a regional system. There would also be a need for a Memorandum of Understanding (MOU).

Mr. Gorman stated that some equipment can be purchased under a U.S. General Services Administration (GSA) contract.

Chair Diamond inquired on the timeline for approvals.

Mr. Gorman stated that this needs approval within the next couple of months. Drug money is funding this and that money runs out on September 30, 2008.

Mr. Stockton says there is no identified procurement organization at this time.

Chair Diamond stated he supports the concept of ARJIS as a focal point, but more information and approval may be needed at the Public Safety Committee level. He advised staff to bring

this issue back at the next meeting with recommendations for procurement, support, staffing, etc. to determine if the Committee is ready to submit for an approval.

7. COPLINK VERSION 4.0 UPDATE (INFORMATION)

Barbara Montgomery (ARJIS Project Manager) gave a PowerPoint presentation with information on the 4.0 Version of COPLINK.

8. BUSINESS AND TECHNICAL COMMITTEE UPDATES (INFORMATION)

Captain Grigsby was in attendance and available for any questions. The next joint meeting is scheduled for Tuesday, February 12, 2008 at the San Diego Sheriff's San Marcos Sub-Station.
