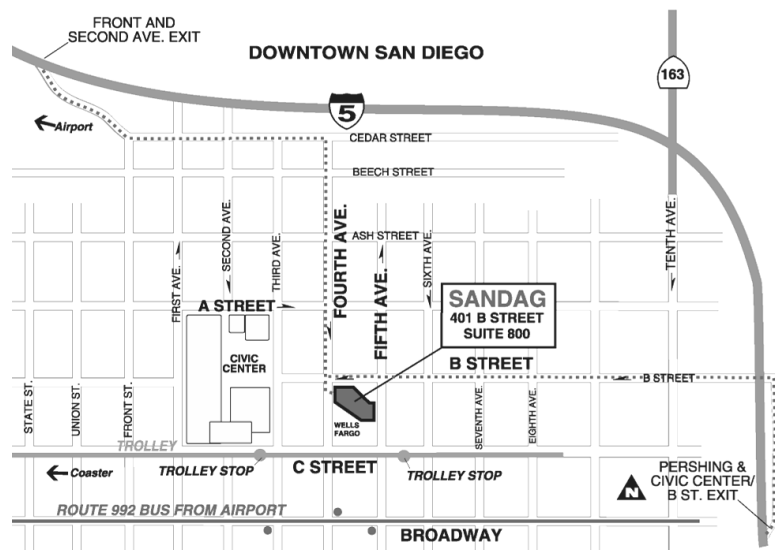

October 3, 2018, Meeting Minutes

In the absence of Chair Manuel Rodriguez (National City Police Department), Chief Craig Carter (Escondido Police Department) called the meeting of the Chief's/Sheriff's Management Committee (Management Committee) to order at 9:54 a.m.

1. Approval of Meeting Minutes (Approve)

Action: Upon a motion by Assistant Sheriff Kelly Martinez (San Diego Sheriff's Department) and a second by Acting Chief Ed Aceves (Coronado Police Department), the Management Committee approved the minutes from its July 11, 2018, meeting. Yes: Chief Roxana Kennedy (Chula Vista Police Department), Acting Chief Aceves, Chief Jeff Davis (El Cajon Police Department), Assistant Chief Jose Tellez (National City Police Department), Chief Frank McCoy (Oceanside Police Department), Acting Chief Investigator Joe Cargel (San Diego District Attorney's Office), Chief Mark Stainbrook (San Diego Harbor Police Department), and Assistant Sheriff Martinez. 3. Public Safety Committee Update (Information)

ARJIS staff provided an update on the Public Safety Committee (PSC) meetings of July 20, 2018, and September 21, 2018. The next scheduled PSC meeting is Friday, November 9, 2018.

4. FY 2019 Automated Regional Justice Information System Annual Work Plan (Approve)

Katie Mugg, Senior Business Analyst, presented a high-level overview of the FY 2019 ARJIS Annual Work Plan. The ten high priority projects are: 1) NIBRS Migration, 2) CA Master Charge Code Table Upgrade, 3) Reverse Interface Development, 4) Network Upgrade, 5) Update Polices (LPR, TACIDS & Retention), 6) Citations & Court Interface, 7) SRFERS Desktop Re-write & Enhancements, 8) eCitations, 9) ONS application operational protocol and Re-write, and 10) Probation ONS initiative. Chief Carter suggested that the seconds-in-command group may be able to assist with project nine, in regard to the ONS protocol.

Action: Acting Chief Aceves made a motion to approve the FY 2019 ARJIS Annual Work Plan's ten priorities with a recommendation that Chief Carter contact Chief Probation Officer Adolfo Gonzales to discuss shared resources for the Probation ONS initiative. Chief Davis seconded the motion. The Management Committee approved the FY 2019 ARJIS Annual Work Plan. Yes: Chief Kennedy, Acting Chief Aceves, Chief Davis, Chief Carter, Assistant Chief Tellez, Chief McCoy, Acting Chief Investigator Cargel, Chief Stainbrook, and Assistant Sheriff Martinez. No: None. Abstain: None. Absent: Carlsbad Police Department, La Mesa Police Department, and San Diego Police Department.

5. Urban Areas Security Initiative FFY 2019 Grant Application Kick-Off (Discussion/Possible Action)

Ms. Mugg and Dale Stockton, Senior Technology Programs Analyst, presented three projects that ARJIS is requesting for UASI funding. The projects include 1) Regional NIBRS Transition, 2) Regional Systems Trainer, and 3) Enhancements to the ARJIS Mobile Program. The Chiefs recommended expanding the proposal for the Mobile Program to include additional smartphones increasing the initial request from \$197,000 to \$400,000. The total requested for all three projects would be \$700,000.

Action: Upon a motion by Chief McCoy, and a second by Chief Kennedy, the Management Committee recommended to the PSC the three regional ARJIS projects for inclusion in the San Diego UASI grant submission to the Urban Area Working Group. Yes: Chief Kennedy, Acting Chief Aceves, Chief Davis, Chief Carter, Assistant Chief Tellez, Chief McCoy, Acting Chief Investigator Cargel, Chief Stainbrook, and Assistant Sheriff Martinez. No: None.
