9A. Memorandum of Agreement with North County Transit District: *TransNet* Debt Financing Program

The ITOC was asked to review and discuss a request by the North County Transit District to borrow \$46 million of Commercial Paper through the *TransNet* Debt Financing program for the COASTER Service Expansion project. The ITOC was asked to review and discuss proposed revisions to the criteria for consistency with the *TransNet* Extension Ordinance provisions as they relate to the *TransNet* Senior Mini-Grant Program, and a proposed allocation of 25% of Senior Mini-Grant Cycle 11 available funding to the Consolidated Transportation Service Agency (CTSA) for mobility management activities, including a maximum CTSA grant request of \$200,000 in Senior Mini-Grant funding per year for all other proposed projects.

Senior Regional Planner Brian Lane and Transit Planner Zachary Rivera presented the item.
